Purpose

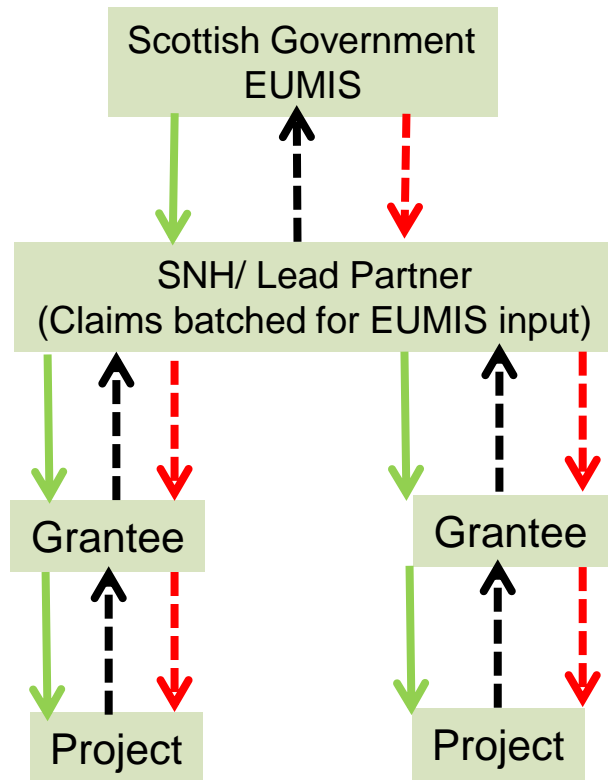
- The purpose of this guidance is to provide an overview of the claims process, key compliance points and the roles of the Managing Authority, Lead Partner and Grantees.
- This document also provides an outline format of the claim form which contains 3 parts; Pay, Non-Pay and Summary. The claim form will need to be submitted to the Lead Partner with all the supporting evidence.
- The document also includes reference to the European Union Management Information System (EUMIS) which is the Managing Authority's claims submission system which will be used by the Lead Partner to submit batched claims.
